Recurrent expenditures have been adjusted to exclude sinking fund balances, as these represent investments in future financial assets and therefore do not impact the overall deficit position.

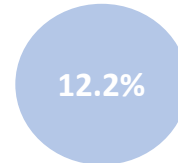
RECURRENT REVENUE GRAPH



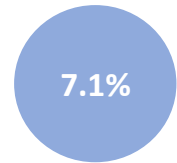
Value Added Tax (VAT)

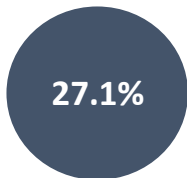
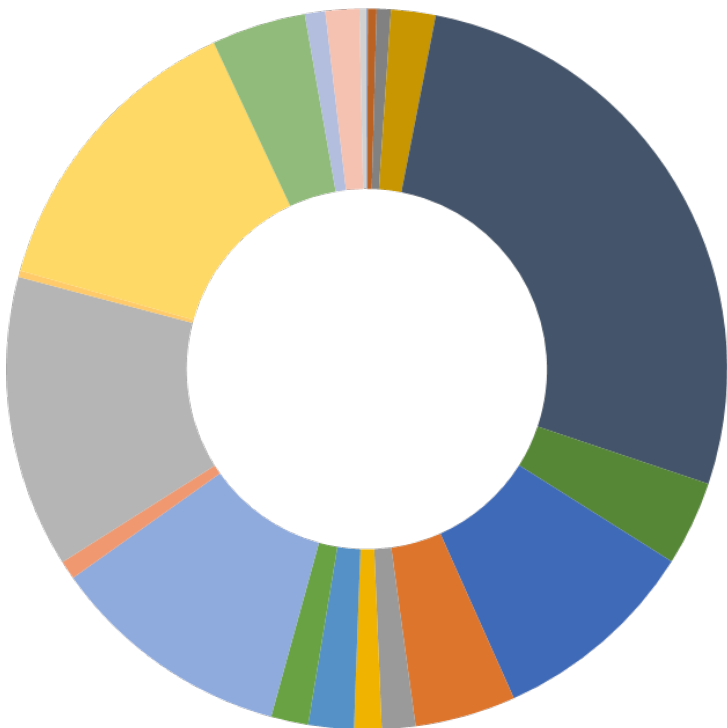

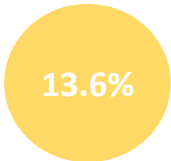
SECTOR ALLOCATION GRAPH

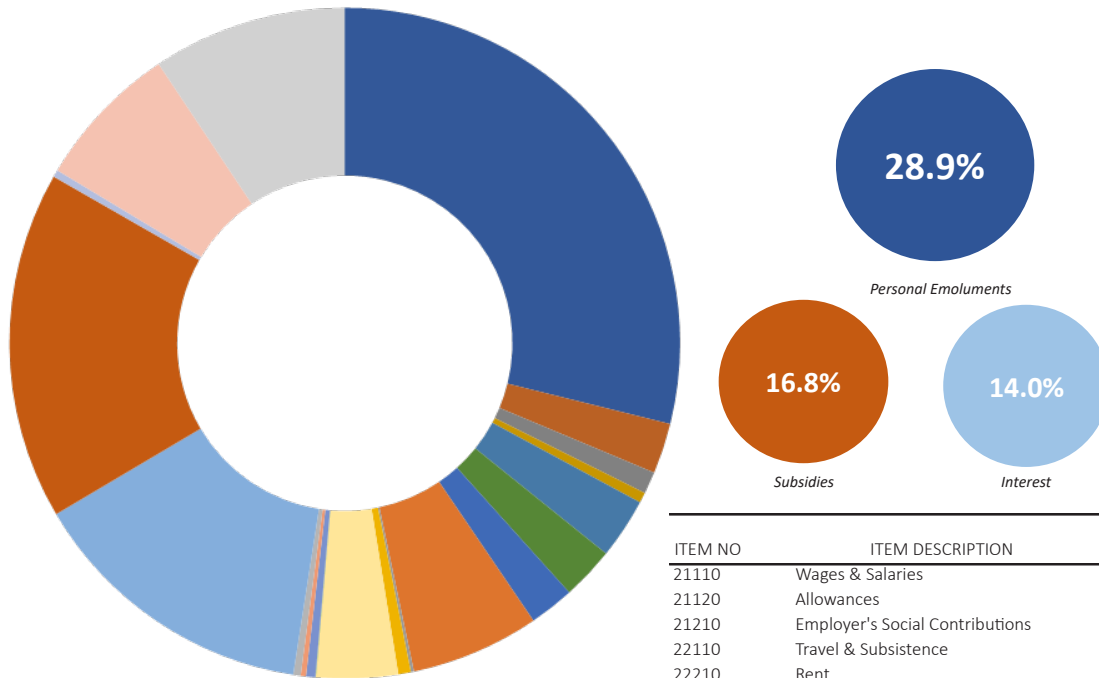

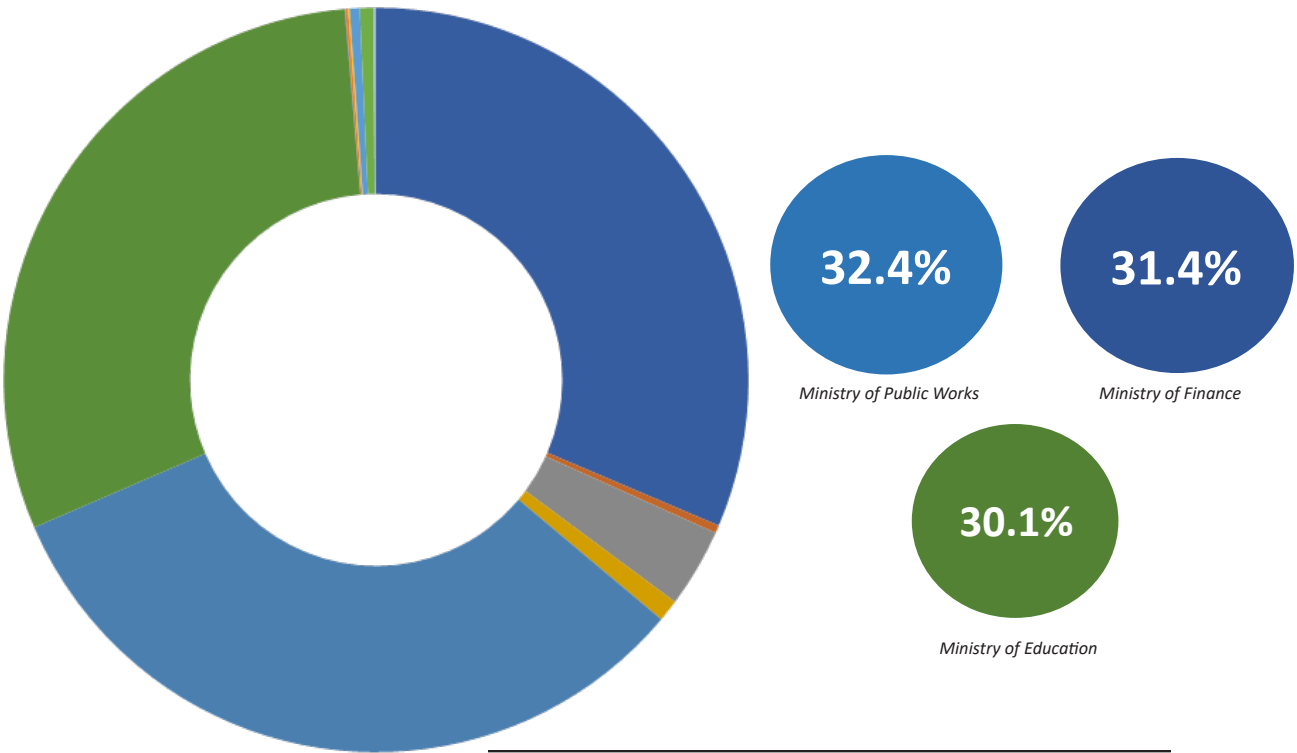
